



Services and Fee Schedule - Northglenn

All charges are due at the time service is rendered or before the treatment session begins.

- Intake Session \$65.00 - Payment required prior to scheduling; non-refundable if appointment missed. If you miss your intake appointment, without at least 24 hour notice, you may reschedule once you have paid the intake fee again. If you gave 24 hour notice about missing the intake appointment, then your initial intake fee will be applied to your rescheduled appointment, but not refunded. If you miss a second scheduled intake appointment, Life Recovery Centers will provide referrals for other agencies to seek services with.
- CO State-mandated books for DUI: Education \$25 or Therapy \$35; not covered by insurance or Medicaid
- Level I Education program consists of (6) 2-hour Education classes \$40/class = \$240 total; not covered by insurance or Medicaid
- Level II Education program consists of (12) 2-hour Education classes \$40/class = \$480 total; not covered by insurance or Medicaid
- Level II Therapy program: Track Level varies by the client; \$40/class

Track A is 21 classes (42 hours) = \$840	Track C is 34 classes (68 hours) = \$1,360
Track B is 26 classes (52 hours) = \$1,040	Track D is 43 classes (86 hours) = \$1,720

- Level II 4+ clients will be charged an additional \$150 after intake for all assessments and also required to pay for Case Management sessions, \$15/15 minutes. Please expect a minimum of 6-10 Case Management sessions, each session 15– 60 minutes, over the course of Level II 4+ treatment
- Interlock Enhancement Classes (IEC) \$40/session; not covered by insurance or Medicaid
- Moral Reconciliation Therapy (MRT) consists of (12) or more sessions depending on the client's effort and progress in the group \$40/session + Required MRT Book \$30.00; book not covered by insurance or Medicaid
- Individual Mental Health/Psychotherapy Individual Session \$75/session or insurance-dependent
- Dialectical Behavior Therapy (DBT) \$40/session
- Relapse Prevention Classes \$40/session

- EMDR (Eye Movement Desensitization and Reprocessing) Individual Session \$95/session or dependent on insurance
- Breathalyzer Testing/Monitoring Fees:
 - DUI/DWAI program enrolled/graduated clients \$2/test
- Urinalysis Testing/Monitoring Fees:
 - DUI/DWAI program enrolled/graduated clients \$15/test
- Mouth Swab Fees:
 - DUI/DWAI program enrolled/graduated clients \$25/test
- If at any time before, during, or after treatment, there is a need for LRC to write a report or detailed letter of any kind, the client is responsible for the fee of \$100/hour. This is a non-negotiable rate and due at the time of the request.

All special charges are due prior to when the service is rendered.

- The ONLY excusable absences for court-ordered treatment are a documented medical excuse, documented illness, death in the family, client incarceration, or vacation with travel permit authorization by Probation Officer submitted to Life Recovery Centers. For DUI Therapy, a therapy absence can only be made up with an individual session with an LRC counselor per state regulations. Individual sessions are \$75/session unless otherwise noted. DUI therapy make-up must be done the week of the missed session. DUI Education cannot be made up.
- Clients who re-enter LRC after being discharged due to absences, overdue balance, or any other non-compliance issue will be charged another intake fee for them to re-start services and placed on Strict Compliance. This fee and any balance on the account MUST be paid before the client is allowed to be scheduled for a re-entry (re-instatement) intake.
